4. First-aid measures

Eye Contact

Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Do

Skin Contact

Wash off immediately with soap and plenty of water while removing all contaminated clothes and shoes. In the case of skin irritation or allergic reactions see a physician.

Inhalation

Remove from exposure, lie down. Remove to fresh air. If not breathing, give artificial respiration. Get medical attention. Risk of serious damage to the lungs (by aspiration).

Ingestion

Do NOT induce vomiting. Never give anything by mouth to an unconscious person. Drink plenty of water. Call a physician immediately. Clean mouth with water. Aspiration hazard. If possible drink milk afterwards. Call a physician or poison control center immediately. If vomiting occurs naturally, have victim lean forward.

Personal Precautions

Remove all sources of ignition. Take precautionary measures against static discharges.

Environmental Precautions

Do not flush into surface water or sanitary sewer system. Do not allow material to contaminate ground water system. Prevent product from entering drains. Local authorities should be advised if significant spillages cannot be contained.

Methods for Containment and Clean Up

Soak up with inert absorbent material (e.g. sand, silica gel, acid binder, universal binder, sawdust). Prevent product from entering drains. Sweep up and shovel into suitable

containers for disposal. Keep in suitable, closed containers for disposal. Wear self-contained breathing apparatus and protective suit. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment. Do not flush into surface water or sanitary sewer system.
